

SMARTAP TERMS OF SERVICE

SmarTap's e-Valve is the world's next generation shower system ("**Product**"), a powerful and unique way to control your entire water system.

SmarTap' Services include a mobile application which enables users ("**You**", "**Your**" or "**Users**") to remotely connect with the User's SmarTap's e-Valve – for the purposes of (i) controlling the Product, or (ii) any other services related thereto. These terms outline the Product related services under our Website and unique Mobile App (the "**Services**"). Along with purchasing the Product, you received Terms of Use regarding installing and using the Product at your own home. You acknowledge and agree that the Terms of Use you received with the Product are incorporated by reference into these Terms and Conditions.

These Terms and Conditions (these "**Terms**") constitute a legal agreement between SmarTap and yourself. By accessing or using the SmarTap Internet site located at <http://www.smartap-tech.com> ("**Site**" or "**Website**"), purchasing the Product or downloading and using our mobile app ("**Mobile App**") you agree that you have read, understood, accept and agree to be bound by these, which together with our privacy policy govern SmarTap' relationship with you in relation to this website and the Mobile App. SmarTap's Mobile App is intended to be used solely with SmarTap's Product. SmarTap reserves the right to modify these Terms at any time, and without actual notice to you. By entering and/or using this Website/Mobile App following any modification to the Terms, you agree to be bound by any such modification to the Terms.

If you disagree with any part of these Terms, please do not use our Website and our Mobile App.

The term 'SmarTap' and/or 'us' or 'we' refers to the owners of this website and the Mobile App and their affiliates and subsidiaries, and is used only for convenience and not intended to be an accurate description of ownership, operation or corporate/legal relationships. The term 'you' refers to the user or viewer of our website.

The use of this Website and/or Mobile App is subject to the following terms of use:

1. SMARTAP'S PRODUCT IS NOT INTENDED FOR USE BY PERSONS UNDER THE AGE OF 13. IF YOU ARE UNDER 13 YEARS OLD, YOU MAY NOT USE THE SERVICE OR PROVIDE SMARTAP WITH ANY PERSONALLY IDENTIFIABLE INFORMATION. If You are 13 or older but under the age of 18, You represent that You have reviewed these terms and conditions with Your parent or legal guardian to make sure that You and Your parent or guardian understand these Terms and Conditions. If You are a parent or guardian permitting a person under the age of majority in his or

her resident jurisdiction (a "**minor**") to use SmarTap's Product and /or Mobile App and / or Website, You agree to: (i) exercise supervision over the minor's use of SmarTap's Product and /or Mobile App and / or Website; (ii) assume all risks associated with the minor's use of SmarTap's Product and /or Mobile App and / or Website, including the transmission of materials, content or other information to and from third parties via the Internet; (iii) assume all liabilities resulting from the minor's use of SmarTap's Product and /or Mobile App and / or Website, including applicable payment obligations; (iv) ensure the accuracy and truthfulness of all information submitted by the minor; and (v) provide the consents contained in these Terms and Conditions on behalf of the minor.

2. We may ask You to confirm that You have had Your Parent's or guardian's permission and that they have agreed to these Terms and Conditions on Your behalf, and even if we do not do this, we shall assume that this is the case and will provide the Service on this basis.
3. SmarTap's Website is intended to provide general information about SmarTap to potential customers, business partners, investors, and employees. Such information about SmarTap may include, without limitation, a description of its products and services, financial performance, and potential employment opportunities.
4. 6. You may use the Website and/ or Mobile App for your own personal use in respect of your domestic Product only provided that You comply fully with this Terms and Conditions. You are not allowed to copy, disseminate or modify the Website/Mobile App, any part of the Website/ Mobile App, or our trademarks in any way. You are not allowed to attempt to extract the source code of the Website/ Mobile App or translate the Website / Mobile App into other languages, or make derivative versions. You shall not interfere or attempt to interfere with the operation or use of SmarTap's Product, Website and / or Mobile App, in any way through any means or device including, but not limited to, spamming, hacking, and uploading computer viruses or time bombs, or any

7. Permission to access Customer's Mobile Device Features. After downloading SmarTap's Mobile App to your mobile device, the Mobile App may ask you to access different features on your mobile device. Permission is required regarding the following features: (a) Wi-Fi - in order for the Software to connect with Product; (b) BLE –in order for the Software to connect with Product; (c) personal data and details –in order to tailor the Mobile App to the your needs – please see in addition our Privacy Policy; (d) GPS–in order to obtain your mobile device location (at the time of the Product installment); (e) camera/pictures–in order to apply a friendly user interface; (f) allow push notifications–in order to get real time notification; (g) email access–in order to verify users, and communicate with the user.
8. The Service is made available to you through the Mobile App and includes (i) the Mobile App; (ii) any software that is made available to you by SmarTap and accessed by you in connection with the Service; (iii) the products, services, and features made available or provided to you by SmarTap at its discretion in connection with the Service; and (iv) the content, text, documents, descriptions, products, graphics, photos, sounds, videos, interactive features, trademarks, service marks and logos, contained in or made available through the Service.
9. In addition, the Service through the Mobile App and the communication with the Product installed at your place are made available to you as long as you have a connection to the Internet (Wi-Fi or 3G). SmarTap shall not be liable regarding any forbidden and / or reckless and / or malice use of the Product and the Mobile App and / or the Website, which may cause damage (direct, indirect, incidental, special etc.) to the Product and the Mobile App and / or the Website and / or the location where the Product is installed, other than the warranties SmarTap must provide to you in accordance with the Israeli Law.

24. Miscellaneous These Terms shall be governed by the law of the State of Israel, exclusive of its choice of law rules. Any action to be brought in connection with these Terms or the Site shall be brought exclusively in the competent courts in the city of Tel-Aviv/Jaffa, and you irrevocably consent to their jurisdiction.
25. These Terms constitute the entire agreement between SmarTap and you pertaining to the subject matter hereof. Nothing contained in these terms shall be construed to limit the actions or remedies available to SmarTap with respect to any prohibited activity or conduct. Nonenforcement of any term of these Terms does not constitute consent or waiver, and SmarTap reserves the right to enforce such term at our sole discretion. This Website/Mobile App is owned and operated by SmarTap. Your privacy on the Internet is of the utmost importance to us. At SmarTap, we want to make your experience online satisfying and safe.

Because we gather certain types of information about our users, we feel you should fully understand our policy and the terms and conditions surrounding the capture and use of that information. This privacy statement discloses what information we gather and how we use it.

INFORMATION SMARTAP GATHERS AND TRACKS

SmarTap Gathers User Information In The Following Processes:

Joining our Mobile App requires you to provide us some personal details as: your name, user name, password, email address etc, in order to create to each user a personal account. Without these details you won't be able to use SmarTap's Mobile App. Part of our services requires additional information in order to provide better service to you. If you wish to update your Personal Information, please write us to info@smartap-tech.com. It is clarified that you are not obliged to provide us with your personal information, however, part of our Mobile App services will not function without it.

By installing our Product, you agree that the Product shall gather and send to our servers information measured by the Product, including water pressure, the uses done with the Product, number of showers, the amount of water used during showers, temperature of water, the length of each use of water, etc. The Mobile App / Website may present to you this information on your personal account. However, the Mobile App / Website doesn't make any other use of this information.

SmarTap uses any information voluntarily given by our users to enhance their experience in our Websites and our Mobile App, whether to provide interactive or personalized elements on the Website / Mobile App or to send you a push notifications regarding the product installed at your place, and for better prepare future content based on the interests of our users.

As stated above, we use information that users voluntarily provide in order to send out push notifications regarding the product installed at your place and to enable users to participate in polls, surveys, message boards, and forums on our Website/ Mobile App. SmarTap never shares your personal information with any third parties, including advertisers, sponsors or partners.

SmarTap uses certain information to allow it to provide better services regarding the Product installed at your place. SmarTap collects the details provided by you, together with information we learn about you from your use of our Services, use of the Product and the Mobile App, and your visits to our Website and other sites accessible from them.

When we use tracking information to determine which areas of our sWebite users like and don't like based on traffic to those areas. Moreover, we check the use of the Mobile App – which feature is more useful and which feature is not as useful or missing from our Mobile App. We do not track what individual users read or use, but rather how well each page / feature of our Mobile App performs overall. This helps us continue to build a better service for you. We track those uses as one of many measures of what best served the interests and/or need of our users. We will not

disclose any information about any individual user except to comply with applicable law or valid legal process or to protect the personal safety of our users or the public.

We may elect to keep archives of all or parts of the Website/ Mobile App, but we cannot guarantee that anything available on the Website/ Mobile App, or any records or information relating to the Website / Mobile App, will be archived, or that any archives will be preserved or made publicly available. We may delete any such information without notice, at our sole discretion.

Cookies. Our Website and Mobile App use cookies to monitor browsing preferences. We may place "cookies" in the browser files of your computer/Mobile. The cookie itself does not contain Personal Information although it will enable us to relate your use of SmarTap's site/Mobile App to information that you have specifically and knowingly provided. But the only personal information a cookie can contain is information you supply yourself. A cookie can't read data off your hard disk or read cookie files created by other sites. SmarTap uses cookies to track user traffic patterns (as described above). Our advertising system delivers a one-time cookie to better track ad impressions and click rates. You can refuse cookies by turning them off in your browser. If you've set your browser to warn you before accepting cookies, you will receive the warning message with each cookie.

SmarTap operates secure data networks protected by industry standard firewall and password protection systems. Our security and privacy policies are periodically reviewed and enhanced as necessary and only authorized individuals have access to the information provided by our customers.
